PRICES: All prices and availability are subject to change, prior to receipt of deposit.

PAYMENTS: A 3.5% bank processing fee will be added to all credit card payments. Add \$35 fee to bank wire transfers.

TRAVEL AGENTS: Unless otherwise specified, prices are net, non-commissionable.

BOOKING: A non-refundable payment of 50% of the total tour and/or tickets cost per person is due to confirm your reservation.

BALANCE: The total balance is due no later than 1/15/2018.

CANCELLATIONS & FEES: All cancellations must be made in writing. If, after receipt of deposit by Sportstours, a cancellation is made by the client for any reason, the following cancellation fees apply: 1) All deposits are non-refundable. 2) Failure to submit final payment to Sportstours by payment due date constitutes full cancellation and complete forfeiture at that time of all monies paid to Sportstours. 3) If a cancellation is made prior to receipt of payment, but the balance payment has not been made, you may still be liable for the full package cost. 4) Any cancellations made after receipt of payment will result in 100% of the total tour/tickets cost per person being forfeited. 5) Any cancellations made after receipt of payment will result in 100% of all monies paid to Sportstours being forfeited.
