

TERMS & CONDITIONS

PRICES: All prices are based on double occupancy, are subject to change.

TRAVEL AGENTS: Unless otherwise specified, prices are net, non-commissionable. Commission can be added on.

BOOKING: A non-refundable deposit of 50% of the total tour cost per person is due to confirm your reservation. A 3.5% processing fee will be added on for credit card sales. No additional fees for payment by check or bank wire transfer.

BALANCE: The total remaining balance is due no later than March 1, 2018.

SINGLE SUPPLEMENT: All tour rates are based on two people sharing a room. Single occupants must make up the difference in price the second person would pay for the double occupancy rate.

CANCELLATIONS & FEES: All cancellations must be made in writing. If, after receipt of deposit by Sportstours, a cancellation is made by the client for any reason, the following cancellation fees apply: 1) All deposits are non-refundable. 2) Failure to submit final payment to Sportstours by payment due date constitutes full cancellation and complete forfeiture at that time of all monies paid to Sportstours. 3) If a cancellation is made prior to March 1, 2018, but the balance payment has not been made, you may still be liable for the full package cost. 4) Any cancellations made prior to March 1, 2018 will result in 50% of the total tour cost per person being forfeited. 5) Any cancellations made after March 1, 2018 will result in 100% of all monies paid to Sportstours being forfeited.
